Chemicals to Avoid by Product Type	
Makeup (Eyes & Face)	Carbon black, Ethanolamine compounds, BAK, Prime yellow carnauba wax, Formaldehyde and formaldehyde-releasing preservatives, Aluminum powder, Retinyl acetate or retinyl palmitate, heavy metals, Titanium dioxide
Makeup (Lips)	BHT (butylated hydroxytoluene), PETROLATUM (petroleum jelly, mineral oil)
Nail Polish	Formaldehyde, toluene, DBP, formaldehyde resin, camphor, ethyl tosylamide, and xylene
Shampoo	Polyethylene glycol (PEG compounds), Methylisothiazolinone and methylchloroisothiazolinone, COAL TAR, 1,4-DIOXANE
Sunscreen	Benzalkonium chloride, Oxybenzone, BENZOPHENONE AND DERIVATIVES, Oxybenzone, Octinoxate, Octisalate, Octocrylene, Avobenzone, Padimate O
Soap	triclosan and triclocarban
Toothpaste	Sodium Lauryl Sulfate (SLS), Triclosan and Triclocarban, PEGs (polyethylene glycols) and Propylene Glycol, DEA (diethanolamine), Carrageenan
Moisturizer	BENZALKONIUM CHLORIDE
Fragrance	BUTOXYETHANOL, Benzophenone, Nitrosamines, Ethanolamine Compounds (MEA, DEA, TEA And Others),
Deodorant	Aluminum Compounds, Steareths, Triclosan, Propylene Glycol, TEA and DEA
Conditioner	Ethanolamines, Parabens, Octinoxate, Oxybenzone, Formaldehyde releasing preservatives, Sodium Laureth Sulfate

Shop Small.	The top 7 cosmetics companies on store shelves regularly use "chemicals of concerns" in products. Find small brands & support them with your loyalty.
Recognize "Green Washing."	Claims of "natural" and "nontoxic" are unregulated and must be examined carefully. non-GMO verified, Leaping Bunny (cruelty free), EWG-verified, non-GMO verified, EWG- verified, ECOCERT
Simplify.	Gravitate to shorter ingredients lists, use fewer products and

Why should you care?

1 in 8 of the 82,000 ingredients used in cosmetic and personal care products are hazardous industrial chemicals.

The average American uses nine personal care products – containing 126 chemicals – every day.

The EU currently bans 1500 cosmetics ingredients - while the US bans fewer than 10. $\,$

Any ingredient that ends in 'paraben'
