Introduction

The 5-Step Animal Welfare Rating Program promotes and facilitates continuous improvement in animal agriculture, encourages animal welfare friendly farming practices, and better informs consumers about the animal farming systems they choose to support. It is a certification program developed by the Global Animal Partnership, to change the landscape of animal agriculture through a positive, rewarding, multi-stakeholder approach.

Who Is Global Animal Partnership? An international nonprofit charitable organization founded in 2008 with the primary mission of facilitating and encouraging continuous improvement and higher welfare in animal agriculture, principally through its signature program—the 5-Step Animal Welfare Rating Standards.

What Is the 5-Step Animal Welfare Rating Program?

- The 5-Step Animal Welfare Rating program is a multi-tiered system that, designed to promote continuous improvement in animal agriculture.
- Each set of tiered standards (Steps) has its own requirements for each particular Step level. Each Step Rating has its own distinct label to affix on products to identify the particular Step level achieved.
- The 5-Step Animal Welfare Rating Standards:
- Inspires producers to move up the welfare ladder;
- Enables engagement with a broad spectrum of farmers and ranchers, rather than a minority segment of a niche agricultural community:
- Allows for greater product supply of higher welfare offerings for expanded consumer options;
- More accurately and justly rewards and recognizes producers for their specific welfare practices;
- Encourages innovation by farmers and ranchers, and
- Better informs consumers about the production systems they may choose to support.
- Independent, third-party certification companies conduct the audits and verification in accordance to the 5-Step standards. Using third parties, Global Animal Partnership is best positioned to remain objective and maintain the integrity of the 5-Step program.

The 5 Steps

STEP 5+	ANIMAL CENTERED; ENTIRE LIFE ON SAME FARM
STEP 5	ANIMAL CENTERED; NO PHYSICAL ALTERATIONS
STEP 4	PASTURE CENTERED
STEP 3	ENHANCED OUTDOOR ACCESS
STEP 2	ENRICHED ENVIRONMENT
STEP 1	NO CAGES, NO CRATES, NO CROWDING

5-Step Overview

A multi-tiered Animal Welfare Standards provides a unique approach to farm animal welfare certification. Each set of Animal Welfare Standards—from Step 1 to Step 5+—has its own requirements that must be met before a farm can be certified. The main emphasis of the standards is taking an animal-centered approach – looking at what the animals are showing us through their physical condition and their behavior.

- Step 1 No Cages, No crates, No crowding
- Step 2 Enriched environment
- Step 3 Enhanced Outdoor access
- ■Step 4 Pasture centered
- Step 5 Animal centered, Physical alterations prohibited
- Step 5+ Animals live entire life on integrated farm

Benefits of The 5-Step Animal Welfare Program

- Provides transparency for consumers on animal production systems
- Encourages and support farmers and rancher to move up the animal welfare ladder
- Recognizes producers for their commitment to animal welfare practices
- Offers a wider variety of products to consumers and retailers
