## **Report Dispositions**

Cleared by Arrest: Physical arrest, someone in custody.

Warrant Obtained: Case cleared, warrant obtained, but suspect has not been arrested.

Cleared by Citation: Includes adjudication, traffic, or parking

Cleared Exceptionally: Indicates issue has been fully investigated, successfully resolved with no further police action.

*Criminal:* Offense was solved but did not include an arrest/citation. *Crime was solved, we know who did it, but no arrest was made.* Non-Criminal: Incident resolved with no follow up required (runaway returned, domestic resolved, civil matter, information for police only).

Unfounded: No offense occurred nor was attempted.

TOT: Case turned over to another Government, or Law Enforcement Agency.

Pending: Case continues to be investigated.

Inactive: Unable to resolve issue, identify a suspect, or develop PC for arrest. Inactive (closed) pending further leads.

#### **Visitation Interference: NTA**

Purpose: Deter unlawful interference with a non-custodial parent's visitation.

Definitions: In JOINT custody arrangements, BOTH are custodial and neither can commit the offense.

Only a SOLE custodial parent has the ability to commit a violation (not allowing the visitation to take place).

If the child custody agreement (Parenting Time) indicates "joint parenting, joint custody, shared custody, or anything other than SOLE custody, the statute DOES NOT apply.
