### 🔗 Web Resources - Testing (cont)

aViewer (Accessibility Viewer) is a tool for Windows that displays the accessibility API information (MSAA, IAccessible2, UI Automation, ARIA, HTML DOM) exposed by web browsers to the operating system, and thus to any assistive technology (AT) such as screenreaders.

tota11y is an accessibility visualization toolkit.

aXe is a JavaScript accessibility automated testing engine

Automated Accessibility Testing Tool is a JavaScript accessibility automated testing engine

Functional Accessibility Evaluator (FAE) evaluates a website or a single web page based on the WCAG 2.0 Level A and AA requirements.

AccessLint integrates with GitHub to test code as it's uploaded to GitHub.

### 🗨 Assistive Technology- Screen Reader

**NVDA** (NonVisual Desktop Access) is a free screen reader which enables blind and vision impaired people to use computers.

FreedomScientific **JAWS** (Job Access With Speech) is a commercial screen reader that allows blind and visually impaired users to read the screen either with a text-to-speech output or by a refreshable Braille display.

AI Squared's **Windows-Eyes** is a commercial screen reader which can be registered for free if you have Microsoft Office

Apple's **VoiceOver** is the default option available on Mac, iPhone, and iPod devices.
