INTRODUCTION

Constructed to give effect to transformative vision of Constitution

Applies to both the state and private persons

Range of rights are protected

(post-liberal text aimed at facilitating social + economic transformation of SA 🐸)

Structure of litigation differs from other branches of law

BOR **always** binds the state and, in some circumstances, private parties

If rights are infringed, is the infringement justifiable i.t.o Limitation

Clause s36?

Enables constitutional rights to be limited for a certain limited + democratically justifiable purpose

LIMITATIONS CLAUSE s36

- **★** Proportionality test applied to determine whether limitation is reasonable + justifiable → balance b/t NB limitation objective + extent which right is limited
- * Must consider relevant factors:
 Relation b/t
 Ilimitation +
 purpose,
 Importance +
 purpose of limitation, Nature of right,
 Nature + extent of
 Ilimitation
- ★ Legitimate objectives for limiting rights: Protecting rights of others, Public Health, Public Morals, Promoting social justice, National Security
- Only deals with BOR. Some rights may not be limited, even in S.O.E (absolute/ non-derogable rights)
- Relationships b/t rights might imply limitation on one of them
 e.g right to life vs right to bodily + psychology integrity
- formulation of right might imply limitation on one of them
- e.g no unfair discrimination vs fair discrimination (u18 can't vote)
- Many rights can be limited/ narrowed in order to prevent conflicts with other right/ or certain general interests

- ★ Can X go to court to claim their right is infringed?
- Is alleged person bound by the duties imposed BOR?
- ♣ Does BOR apply indirectly or directly to dispute?
- 2) Limitation/
 Substantive
 Stage
- ♠ What is the scope of the right and does law/ conduct infringe on right?
- ♣ If infringement occurs, is it justifiable i.t.o Limitation Clause s36

STRUCTURE OF BOR LITIGATION 🚓 (cont)

doesn't promote values of BOR

3 stages set out in the operational provisions of BOR and regulates the questions courts need to consider. They are:

- State's duty to respect, protect, promote, + fulfill BOR [s7]
 - Suspension of rights in S.O.E [s37]
 - Who is bound by BOR [s8]
- Who has standings to enforce rights [s38]
 - Interpretation of rights [s39]
 - Limitations of rights [s36]
