#### The Eisenhower Doctrine: Overview

Date & Announced in January 1957 by
Context: President Dwight D. Eisenh-

ower.

Purpose: Extend containment to the

Middle East amid fears of Soviet

influence.

Doctrine US would provide economic and Princi-military aid to any Middle
ples: Eastern country resisting communism.

Authorised direct US intervention, including troops if necessary.

Part of a broader Cold War strategy of global containment beyond Europe and Asia.

Significance: Explicitly tied containment to resource-rich regions (oil) and

strategic geopolitics.

Reinforced the US commitment to preemptive defense against Soviet expansion.

# Expansion of Containment Under Eisenhower

While Truman

Doctrine focused on

Europe and initial

global hotspots,

Eisenhower Doctrine:

Globalised containment further →
Middle East and
non-aligned
nations.

Recognised that communism could spread politically, economically, and ideologically.

Encouraged covert operations (CIA-led coups, propaganda campaigns).

### **Psychological Component of Containment**

Eisenhower, a military strategist, understood that modern warfare was not just conventional:

Ideology and influence mattered.

Psychological operations (psyops) became part of national security.

Fears of Soviet "brainwashing" and subversion became central to US intelligence priorities.

# MKULTRA as a Tool Within Eisenhower Doctrine Logic

MKULTRA (1953–1973) emerged just before the Doctrine but was intensified under Eisenhower.

Doctrine Conventional military power.

logic →
US must
maintain
superiority in:

Technological and scientific research.

Psychological operations and mind control

Connections:

Both sought prevention of communist influence, though Eisenhower's doctrine was public and military, while MKULTRA was covert and psychological.

Both reflected paranoia about Soviet innovation — if the USSR could control minds, the US needed its own methods.

# MKULTRA as a Tool Within Eisenhower Doctrine Logic (cont)

MKULTRA research on LSD, hypnosis, and interrogation aligned with fears of subverting US allies or destabilising hostile states.

#### **CIA Covert Operations & the Doctrine**

Eisenhower Doctrine encouraged CIA interventions in the Middle East (e.g., 1953 Iran coup as precedent).

MKULTRA techniques were considered potential tools to: Extract intelligence from suspected communist agents.

Influence political

actors covertly.

Maintain US
strategic advantage
in ideological
warfare.

#### Case Studies / Examples

Iran CIA coup to depose Mossadegh
 (1953): → demonstrated link between doctrine, containment, and covert psychological operations.

Fear of POWs in Korea (1950–1953)

Soviet created urgency to develop

Mind interrogation and mind control

Control: methods → MKULTRA.

MKULTRA experiments could have been used in theory to manipulate foreign leaders or operatives under Eisenhower Doctrine logic.

## **Ethical and Strategic Implications (cont)**

Military/political containment justified extreme measures.

MKULTRA's secret human experimentation mirrored covert risks in foreign policy.

Both illustrate the secrecy, paranoia, and totalizing logic of Cold War containment.

## **Key Takeaways**

Eisenhower Doctrine = global containment, Middle East focus, public and military-oriented.

MKULTRA = covert psychological containment, global reach, secret and experimental.

Both were driven by fear of Soviet influence and need to preempt communist expansion.

MKULTRA can be seen as the psychological and covert complement to the Doctrine's public, military, and economic strategies.
